I HEREBY DECLARE THAT I HAVE COMPLIED WITH & UNDERSTAND THE FOLLOWING:

- 1. Entry fee** is £3.00 per cage (inclusive of VAT), Deadstock £2.00 per lot (inclusive of VAT), Hatching Eggs per ½ Dozen £1.20 (inclusive of VAT). Cheques to be made payable to FLA Ltd and to accompany the entry form. Entries will close Friday 18th September.. Entries will not be accepted without full payment.
- 2. Vendors Commission** will be charged on all lots at 15% (plus VAT) with a minimum of £1 a lot (plus VAT).
- 3. Reserves** are to be made per cage and stated clearly on the entry form. Any Amendments to Catalogue & reserve prices must be made to the Market Office by 1pm on the day prior to sale. **NO AMENDMENTS/RESERVES WILL BE ACCEPTED ON DAY OF SALE.**
- 4. Entries** must have a maximum of 4 birds per cage, with no single cockerels in the poultry and bantams and no single drakes in the domestic waterfowl. Also a maximum of 1 male bird per cage in all sections. No entries of chicks or birds described as 'As Hatched' will be accepted.
- 5. Sections** of the sale will include **1** Large Fowl Poultry, **2** Bantams, **3** Domestic Ducks, **4** Guinea Fowl, **5** Ornamental Pheasants, **6** Quail, **7** Pigeons/Doves, **8** Ornamental Ducks **9** Domestic Geese **10** Turkeys, **11** Peafowl, **12** Ornamental Geese & Swans, **13** Associated Deadstock. **14** Hatching Eggs Please identify clearly on your entry form which sections your entries should be in.
- 6. All birds** must be purebred and true to type, fit and healthy and free of any diseases. The auctioneers hold the right to refuse any entries which don't meet these requirements.
- 7. Any changes** to the catalogued entry must be made to the Market office by 1pm Day prior to sale.
- 8. All deadstock** will be sold as seen. All Electrical items will to be PAT Tested on Day of sale at a charge of £2.00 per item.
- 9. Water containers and food** will not be provided with the cage, it is the vendor's responsibility to provide their birds with food and water.
- 10. Wildfowl** must meet with Defra & Natural England's regulations and be closed rung when necessary.
- 11. Vendors** must health check all birds they intend to bring to the sale before leaving their premises, all birds must be free from all notifiable diseases and must be transported to the sale in suitable clean crates and carriers. Any birds showing signs of a notifiable disease will be immediately removed from the sale and inspected by a vet at the expense of the vendor.
- 12. Birds** entered in the sale must not have been mixed with birds from another gathering in the 7 days leading up to the sale date.
- 13. Hatching Eggs** will be sold as seen with no warranty.
- 14.** I confirm that i have read the full terms, conditions and bio security rules on both sides of this entry form, I am also the legal owner of all stock that I have entered into this auction.
