SHEEP EID REQUIREMENTS:

BORN AFTER 01.01.10 – Must be double tagged (1 x electronic) except those intended for slaughter within 12 months of age. It is recommended these are identified with a single electronic slaughter tag which just displays the flock number.

BORN AFTER 11.01.08 – Must be double tagged (or single tagged & tattooed) if they live beyond 12 months. If they are still on the holding of birth they must be double tagged with a duplicate of the existing tag. If not on the holding of birth they must be double tagged either with a duplicate of the existing tag or with two of the keeper's own tags.

BORN BEFORE 11.01.08 – Those already individually tagged do not need any further tags. Those identified but not with an individual ID must be double tagged with an individual ID if on the holding of birth. If not on the holding of birth they must be double tagged with a red "R" and any re-identification including the original flock mark or other ID must be recorded on the flock register. Older animals on the holding of birth with no ear tags must be double tagged with an individual ID. Those not on the holding of birth with no ear tags must be double R-tagged (red) with an individual ID.

INDEMNITY CHARGE AS FROM 1ST MARCH 2020

15p (incl vat) Per head will be deducted from all Prime & Cull Sheep to cover any rejected meat/condemned carcasses at abattoir. This is subject to the discretion of the Auctioneers. This is valid for 48hrs after purchase.

I HEREBY DECLARE THAT:

1. I am the owner/owner's agent of the animal(s) overleaf.
2. **GOOD ON TOOTH & UDDER** – Ewes described thus should be correct in the mouth i.e. FM/no corner teeth missing and not diseased/deformed in the udder.
3. **EWES** – An allowance of **25%** of the selling price shall be made to the purchaser by the vendor for any ewe which does not answer the age of the Lot (unless otherwise stated at the time of sale) BUT NO ALLOWANCE shall be made for any ewe which may be found to be younger than the description given. Likewise, an allowance of **30%** of the selling price shall be made to the purchaser by the vendor for any ewe which is wrong in its udder having been described as good on udder (GOU) subject to verification by the Auctioneers independent expert or supporting Veterinary Certificate. All ewes up to and including FM age are sold as good on tooth and udder unless otherwise stated.
4. I further declare that all prime lambs/hoggets in this consignment have been mouthing during the past 48 hours and none have scaled up a permanent incisor. In the event that any sheep in this consignment are subsequently discovered within 2 working days of the sale to have erupted a permanent incisor then I will be liable to recompense the purchaser an amount of half the value of the average price per head of the consignment, as recommended by the Livestock Auctioneers Association.
5. The stock have been examined and show no signs of any disease or condition that may affect the safety of meat derived from them and comes from a holding which has had no movement of FMD susceptible animals onto it in the 6 days prior to the Market, other than the permitted exceptions.
6. The movement is in accordance with the General Licence Conditions.
7. The Vehicle has been fully cleansed and disinfected prior to loading of stock.
8. Sheep and goats on the holding are not under movement restrictions for animal disease or public health reasons.
9. Withdrawal periods have been observed for all veterinary medicines and other treatments administered to the animals while on this holding and previous holdings.
10. No analysis of samples taken from animals on the holding or other samples has shown that the animals in this consignment may have been exposed to any disease or condition that may affect the safety of meat or to substances likely to result in residues in meat.
11. Frome Livestock Auctioneers Ltd as Auctioneers at Frome Market, act as principals and consequently the RICS Client Money protection Scheme (CMPS) will not apply to protect the Vendor.

12. All stock is sold in accordance with the conditions of sale produced by the Livestock Auctioneers Association (revised 2017) as displayed in the market office.
13. All of the animals listed on the attached/associated paperwork have originated from establishments that have received regular animal health visits from a veterinarian for the purpose of the dedication and signs of disease.
